#### **Message from the State Deputy**

Brothers All,

Lenten Season is Here!!

## It's not as important to give up something for Lent, as it is to GIVE something as a sacrifice.

#### Please read the phishing issues we have been experiencing on our website at the end of my article.

Here is an update to our "Battle of the jersey" between Oregon and Washington starting January 13<sup>th</sup>. Our percentage of goal for COH is at 71.89% as of this writing. We are right on track to make 100% of our goal by June 30<sup>th</sup> for Circle of Honor; however the greatest goal is to beat Oregon in percent goal.

January 13<sup>th</sup> both Oregon and Washington were tied at 51.09%. Ray Prom, Oregon State Deputy, and I issued a challenge. Whoever was behind in percent goal by April 21<sup>st</sup> would have to wear the winner's jersey from a PAC-12 team at the Oregon State Convention. Each State gets to pick which university they want the loser (I do not like that word) to wear.

Right now, Oregon is at 75.00% while we are at 71.89%. Both of our States have had a tremendous four month run. Oregon being smaller that Washington needs to bring in 10 new members to Oregon's 6 just to stay even. That means we have a lot of ground to make up. We need 17 new members to catch up.

Washington won the Western Round Up challenge that involved 19 States for the months of November, December and January. Oregon started coming on in December and matched us by January 13<sup>th</sup>. Since then they have been on fire, but so have we.

Every council that brings in and exemplifies a new member after January gets one vote as to what jersey the State of Washington wants Oregon to wear at their Convention April 21<sup>st</sup>. The council places a vote for either the Cougars or Huskies. Turn in that vote to Mike Rutland, Membership Director by April 21<sup>st</sup>, provided we are ahead of Oregon, will draw the winning team. Oregon will pick from the Ducks or Beavers.

State Deputy Ray Prom and I are good friends, so we will have fun with this competition, BUT I DO <u>NOT</u> WANT TO WEAR A DUCKS OR BEAVERS JERSEY. BOTH NEED TO BE IN THE WATER AND NOT ON MY BACK, SO PLEASE DON'T LET ME DOWN...

As you know, there have been some phishing issues with mass email messaging through our website. After explaining the situation many times to members in person, phone calls, and emails, we still have some that do not recognize a phishing message. Multiple times I have instructed members to just delete the message, but I still get 30+ messages telling me I have been hacked. I haven't been hacked, but the email was compromised.

The messages are easy to detect by the first few words. It is obvious in the message that no one writes like this. Misuse of words, spelling, and grammar should be clues, but I still get questions. All the recipient needs to do is DELETE the message. If you don't answer, or reply, the phisher will go away and bother someone else.

Since I've had no luck controlling the issue, I will not be communicating with the membership over our website mass mail system. It is very unfortunate because I feel it is important to communicate to the membership. If we do not communicate, we will lose in the long run. It is very unfortunate, but I do not have the time to answer 30+ inquiries every time I send a message.

I am working on another method to send email messages to select groups. If it works, the message will go to GK's, FS's, DD's, State Chairmen and State Officers, but through my person address, avoiding the website. I will need to rely on your GK's, FS's and/or DD's to pass the message along to the members. I have an extensive filter system that I hope will work. Be looking for a c170... email address. That will be from me.

#### I want to make it clear; there is nothing wrong with our State website, just the email portion.

Moving on to Lent, to me it isn't the giving up of things as a sacrifice, but giving as a sacrifice. I never give up something for Lent, but chose instead to give. Just food for thought.

### State Chaplain's Message

My Brother Knights,

The season of Lent is a season of great opportunity. It gives us time to prepare our hearts for the renewal of our baptismal promises at Easter. It helps us develop greater self-mastery through the penances we embrace. It urges us to increase the good we do for our brothers and sisters in need. Lent really is a season of tremendous grace and growth.

It also highlights for us the distinction between our external observance and our interior reality, and the harmony or disharmony that characterizes their relation. We will see that this is a principle that applies far beyond the context of Lent and reaches into the entirety of our spiritual life.

One of the temptations that arise during Lent is that we allow ourselves to be satisfied with mere external observance. We make some kind of prayer commitment, we choose some form of fasting, we resolve to give alms, and we dupe ourselves into thinking that if we can just remain faithful to our "program" until Easter, we will have done a noble thing.

The Lord makes known to us, however, that it is not the sacrifices in themselves that He is interested in, but in the transformation of heart that should be brought about *through* those sacrifices. Our Lenten practices are not ends in themselves, but rather means to an end, namely, the increase of the love of God in our heart. Even the practice of almsgiving is carried out not only for the benefit of others, but also in the hope that our own hearts might be "stretched" to a greater capacity for generous self-gift throughout the year.

This is why, in our preparations for Lent each year, we ought to ask not so much, "What am I going to do?" but "What does the Lord want to accomplish in my heart in this season of grace?" The answer to that question then guides our discernment about what our Lenten observance might look like in practical terms.

As I mentioned above, this is a principle that guides us not only during Lent, but also for the whole of our spiritual life. It's all too easy to get caught in routines of external observance that fail to effect an internal transformation (i.e., conversion of heart). I can go to Mass every Sunday – or even daily! – and say my Rosary and all my other prayers consistently, and not allow those experiences to penetrate any deeper than my mind.

God wants more than just the good we do with our bodies and voices. He wants more than just our mind. He made us for love, and in pouring His love out upon us He invites us to give Him all the love of our hearts.

All this doesn't mean we should halt our external observance if we don't *feel* an interior change! Truly, it's more about what we *intend* than what we *feel*. What I am recommending is that we be more *intentional* about what we are doing, both during Lent and in the context of our day-to-day spiritual practices. That's another way of saying that there is always work we can do to ensure that our *hearts* are more thoroughly engaged in what occupies our mind and body.

Let's all pray for one another, that our Lenten observance might be more than a surface-level engagement. May we respond to the Lord's invitation to "put out into the deep" this holy season and always, opening our hearts to the healing and transforming power of His love.

The pope recalled "the command that God the Father addresses to the disciples on Mount Tabor as they contemplate Jesus transfigured. The voice from the cloud says: 'Listen to him.'"

"The first proposal, then, is very clear: We need to listen to Jesus," he said. "Lent is a time of grace to the extent that we listen to him as he speaks to us."

### State Secretary's Message

#### Brother Knights,

Lent has begun. This holy season prepares us for Christ's glorious triumph over sin and death at Easter. As we prepare to celebrate Christ's Resurrection, let us make a commitment during Lent to grow deeper in relationship with Christ through prayer and participation in the sacrament of reconciliation. At council meetings, devote more time to Spiritual Reflection. As Matthew Kelly writes in his book, *Holy Moments*, "You were made for more." We should tune into the source who created us for more and who desires that we live life to the fullest.

As we prepare spiritually during Lent, preparations are also in full swing for the Annual meeting in May. I mailed the **Certificate of Election** to each council financial secretary on February 12, 2023. Promptly return the Certificate of Election form to me <u>with Council seal affixed</u> after council members elect delegates. I have already received three completed Certificates of Election – thank you. Let me know soonest if your council has not received the certificate of election. Two other important items for the Annual Meeting are **Council Resolutions** and the **Council Annual Report**.

A correction to my February article: Submit **Council Resolutions** to State Advocate Scott Hulse by **March 12**, **2023**, for consideration at the Annual meeting. Do not send council resolutions directly to the State Secretary. Consult with State Advocate Scott Hulse on how to write resolutions in the proper format. The Grand Knight handbook posted on the WSC Website and the Knights of Columbus Officers Online provide instructions on how to write a resolution. Submit resolutions in Word document format only. I will send councils a copy of resolutions to be considered at the Annual Meeting at least 30 days prior for council review.

**Council Annual Reports** are to be written in Word document format and submitted to District Deputies by **April 1**, **2023**. Council Reports should be concise and not exceed one page. Council Reports will be rolled up in the District Reports. District Deputy, State Director and State Chairman Annual Reports are to be written in Word document format and submitted to me by **April 10**, **2023**. All reports will be included in the Convention proceedings that will be published a few weeks following the Annual Meeting.

April 29, 2023, save the date, for the Seattle Catholic Men's Conference hosted by St. Michael Parish in Olympia. Registration details are in the flyer included in this bulletin. Hope to see many Knights there.

### **State Advocate's Message**

#### My Brother Knights

The Washington State Council Bylaws require that resolutions and amendments to the Washington State Council Bylaws must be received by the Washington State Council Secretary, Greg Mahoney, sixty (60) days prior to, for consideration during the Annual Meeting and Convention, 19 - 21 May, 2023. Proposed resolutions and amendments to the Washington State Council Bylaws must therefore be in the possession of State Secretary Greg Mahoney no later than 18 March, 2023.

Please send all proposed resolutions or amendments to the Washington State Council Bylaws to State Advocate Scott Hulse by 12 March 2023 if at all possible so that proposed resolutions and amendments to the Washington State Council Bylaws can be collated and prepared for review by the State Secretary. State Secretary Greg Mahoney will send printed copies of resolutions and proposed amendments to the Washington State Council Bylaws submitted for consideration at the 2023 Washington State Council Meeting and Convention to the Grand Knight of all subordinate Councils for the Council's consideration and comment thirty (30) days before the 2023 Washington State Council Annual Meeting and Convention is to be called to order.

The following guidance has been received from the office of the Supreme Advocate:

"The Laws of the Knights of Columbus permit State Councils to submit to the Supreme Council resolutions that pertain to issues affecting the entire Order. **All such resolutions should be submitted in good faith and in a spirit of charity, unity, and fraternity.** As you prepare for your conventions, please bear in mind the principles and procedures set forth below.

The Supreme Council established the resolutions process to enable subordinate councils to:

(1) Express gratitude or support for a person, a fraternal program, or a policy of the Order;

(2) Amend the Constitution or Laws of the Order;

(3) Express an official position of the Knights of Columbus on matters relevant to the mission and identity of the Order;

(4) Submit nominations for Supreme Director; and

(5) Offer proposals to enhance the Order's fraternal mission.

State Councils should not submit resolutions that: (1) concern monetary expenditures by the Supreme Council, such as financial grants to organizations; (2) deal exclusively with matters of local significance that are relevant only to that particular jurisdiction; (3) recognize, commend, denounce, or criticize individual persons or other organizations; (4) propose changes to administrative policies, functions, or procedures of Home Office Departments; or (5) have been rejected by delegates to the Supreme Council in recent years.

Resolutions that do not conform to these expectations and purposes may be deemed out of order, in which case they would not be published to the Supreme Council and would not be considered by the delegates.

Under the Order's procedures, delegates to the Supreme Council may consider only those resolutions that have been officially adopted by a State Council or submitted to the Supreme Council by the Board of Directors. Resolutions that have not been adopted by the State Council should not be submitted to the Supreme Council. A State Council must affirmatively adopt a resolution for the Supreme Council to consider it. "Adoption" of a resolution by a State Council means that the program, policy, or sentiment expressed in the resolution has the support of a

majority of the delegates to the State Council meeting. By adopting a resolution and submitting it to the Supreme Council, the State Council is effectively stating that it supports the resolution and recommends adoption by the Supreme Council.

A State Council may also use the resolutions process to amend its own by-laws. Upon adoption of a resolution proposing any changes to its by-laws, the State Council shall submit the proposed amendments to the Supreme Secretary, who will forward them to the Supreme Advocate for review and recommendation by a committee of the Board of Directors. The committee will then present the proposed amendments to the full Board of Directors. The Board will consider and vote upon these amendments at its meeting in August. Pursuant to Section 22 of the Laws of the Knights of Columbus, resolutions adopted by a State Council for consideration by the Supreme Council or the Board of Directors, including proposed amendments to State Council by-laws, must be submitted to the **Office of the Supreme Secretary** no later than June 15, [2023].

Please submit these resolutions by email using the following email address: <u>supremesecretary@kofc.org</u> Resolutions received by the Supreme Secretary will be acknowledged in writing and sent to the Office of the Supreme Advocate for purposes of inventory and preliminary review. Once the resolutions are categorized, organized, and published in a booklet, they will be referred to the Committee on Laws and Resolutions. Any resolutions received after June 15 will not be published to the Supreme Convention and will not be considered by the delegates.

Please follow the guidance set forth above. As leaders of your jurisdiction or local council, you should be familiar with the procedure for drafting, reviewing, submitting, and adopting resolutions. For a detailed explanation of the resolutions process and amending State Council by-laws, please review the relevant sections of the Officers' Desk Reference, which are found under the "Council and Assembly Issues" tab."

### State Warden's Message

My Brother Knights,

When I was growing up, the Archdiocese of Seattle ran both a major and minor seminary on Lake Washington, in what is now Saint Edwards state park. Now the only minor seminary in the State is in Spokane, Bishop White Seminary, where 14 men study at Gonzaga while living in community across the street from campus. The men come from Idaho, Washington, Oregon, and California as there are very few minor seminaries in the west anymore. When they graduate, if their vocation persists, they will be placed in a major seminary to study theology and prepare for ordination.

The closest major seminary is Mount Angel in Oregon, run by the Order of Saint Benedict. Mount Angel is one of two major seminaries used by the Archdiocese of Seattle and enrolls six men from the Archdiocese of Seattle. The other three are at Mundelein Seminary in Illinois.

The Diocese of Spokane has two major seminarians, one at Mount Angel and one at Saint Patrick's in Menlo Park, CA.

The Diocese of Yakima has four major seminarians, two at Mundelein and two at Seminario Hispano De Santa Maria De Guadalupe in Mexico.

In total, there are fourteen men in major seminaries for the future support of the 144 parishes in the Archdiocese of Seattle, 45 parishes in the Diocese of Yakima, and 82 parishes in the Diocese of Spokane. This is not enough future priests to support the known needs of the state, and the shortage of priests is the primary reason for consolidation parishes underway in the <u>Archdiocese of Seattle</u>.

What needs to be done? <u>We need more priests</u>. To get more priests, we need more men in formation. Minor seminaries are important parts of formation, the critical first steps. Bishop White is our local minor seminary. It is a vital part of the effort to grow the number of priests in the state.

There are also fraternal considerations. We have a college council (12583) at Gonzaga, sponsored by the Bishop White Seminary. Most of the council officers are seminarians at Bishop White. I am the district deputy for that council and attended a council meeting there in February.

Bishop White hosted me, and offered me room and board with them. It is a bit more spartan than a college residence hall! The chapel is the center of the seminary daily routine, with the seminarians following the Liturgy of the Hours. I joined them for dinner, then vespers, followed by a Knight of Columbus meeting on the Gonzaga Campus. The conversation at dinner was very good and we talked a great deal about the state of K-12 Catholic education and what the long-term strategies for the Church might be. One of the seminarians was completely home-schooled and learned his faith not from a parish school or CCD program but completely from his parents – a sign of the times.

For Catholics worried about vocations to the priesthood, as I am and you should be, this was a mostly reassuring visit. The seminarians are good men, serious about their studies and actively discerning their vocation. The diocese of Spokane has made a huge talent investment, placing two outstanding priests to run the seminary. The Jesuits have contributed a third retired priest. That's three priests for 14 young men - a major bet on the future when there are so many current needs for priests in parishes now. The only concern is the number of seminarians. The state needs more men willing to explore a vocation to the priesthood.

### State Warden's Message Cont'd

Fr. Dan Barnett is the rector of Bishop White, and also chaplain for the Gonzaga College Council 12583 . A graduate of Gonzaga, he has been a knight since he was 18. His chaplain remarks at the council meeting parallel the approach the Church is taking to vocations. He told the knights to not recruit other men to be knights just for numbers, but to live their lives on campus and conduct their council programs in such a way as to inspire others to want to be associated with their efforts. I was very pleased to meet him again.

It bears saying that it is in the interest of the Knights that seminarians participate in College councils and understand immediately the role that councils play in parishes, and in particular our commitment to support our priests and bishops.

Bishop White Seminary has been raising funds for the renovation of McGivney Hall for the Cor Christi program, which will serve men in the critical "propaedeutic" first year. During that year, men "detox" from the main culture and focus on Christ. (It reminds me of my first "plebe" year at West Point.) Its purpose is to form strong Catholic men in the heart of Christ, so that they have a solid foundation for their journey through seminary.

The Knights are called to support the development of McGivney Hall. We have given much; they need more. I encourage all of the Councils and Knights in the State to consider again <u>further donations to their fundraising</u>.

I hope you had a meaningful Ash Wednesday and that your Lenten prayer, fasting, and almsgiving move you closer to Our Lord.

#### W-9s for ASAP grant applications

Below are the W-9s that I currently have available for any council to request. These W-9s belong to organizations have been accepted for grants under the ASAP program. Councils are still required to submit a W-9 form with your ASAP grant application even if the W-9 was submitted by another council. Your council is not limited to supporting these organizations, but be sure to read all of the guidelines for qualifying organizations under Supreme's ASAP program website at https://kofc.org/asap. If you are supporting one of these organizations, send me an email and I will provide you with the W-9.

Some organizations may not be familiar with the IRS W-9 form. Here is a link to a blank W-9: <u>https://www.irs.gov/pub/irs-pdf/fw9.pdf</u>. Your council can give the organization this form and ask them to fill it out. Be sure they complete Part I in its entirety and sign/date the form in Part II, as well. Without Part I and Part II completed, the W-9 will not be considered valid. By filling it out, they're providing their organizations EIN and asserting their 501(c)(3) status.

### **State Membership Director's Message**

My brothers we are now into March, and in 3 months the end of the fraternal year will be upon us. You all have done a wonderful job during February. A total of 64 new online members have been added to our ranks, beating all records for this fraternal year. As of March 1<sup>st,</sup> we are 26<sup>th</sup> in the order attaining 74.56% of our goal and climbing. While we can be and should be proud of our accomplishments, we can not afford to rest. We need 143 new members to achieve our goal by June 30<sup>th</sup>. Additionally, we have been challenged by the State Deputy of Oregon, Ray Prom as mentioned by our State Deputy Kim Washburn in his article. Currently, Oregon leads us by 3.42% in member growth, with Oregon at 77.98% and Washington at 74.56%. Will you help us beat Oregon? We have until the middle of May to beat them. As I've said many times, if <u>everyone</u> brings in just 1 new member this fraternal year, we become unstoppable and will become number one in the order.

This month under the leadership of our State Advocate and Ethnic Council Development Chairman Dr. Scott Hulse and DD7 Federico Lopez, we will be conducting a large Hispanic church drive at St Rose of Lima in Ephrata. For too long our Hispanic Brothers have been underrepresented and served. This will be followed by another large Hispanic church drive and council development in District 7, at San Juan Diego I Basin City. We expect to grow our Hispanic councils from 1 to 3 before the end of this fraternal year.

I'd like to address the large number of online brother knights, 141 to be exact. As good as we are in recruiting new members, we need to complete the job by getting these brothers exemplified, brought before the council admissions committee, voted into the council, and transferred off the prospect list to the council rolls. Brothers, there are enough members sitting on the prospect list for councils to satisfy their membership goals for Star Council, and in some cases Double Star. What's stopping you?

We must now reach out and sell them on the value of joining our councils. The process is simple. When representatives of your council reach out to these brothers the conversation must start with, "Welcome brother to the Knights of Columbus. You are now part of the largest Catholic Family Fraternal organization in the world. You now have over 2 million brother that share the same faith and values as you."

As your conversation continues let them Know what your council has to offer both them and their family. Don't just talk about the breakfasts, dinners and all the work the knights do around the parish. Let them know you would be <u>honored if they would consider joining the council</u>. Set up a meeting and have them fill out Form 1842 Member Experience Interest Survey. This survey will let you know their experience and where their interests lie. Remember it's about them not the council. You are setting the stage for their life experience as a knight and council member. Get them to your councils in person exemplification. If you haven't organized an exemplification team yet, have them view the online exemplification offered by Supreme. #### MARCH 2023 Supreme Chaplain's Monthly Challenge

**But Jesus came and touched them, saying, "Rise, and do not be afraid."** (Gospel for March 5, Mt 17:7) "Do not be afraid" — we read these words often in Scripture. Here, Jesus speaks to the apostles, awestruck at his Transfiguration. In a similar way, the angel told St. Joseph, "Do not be afraid" to take Mary, who had conceived the Christ Child, as his wife. The knowledge that God is with us should encourage and strengthen us. Sometimes, as with the apostles, we are overwhelmed by the mysteries of faith; at other times the challenges of living our faith in a secular culture seem daunting. <u>Questions for Reflection:</u> What are you afraid of? Do your fears prevent you from fully following God's will in your life? How can you imitate the courage of St. Joseph?

Faith Director: Before Easter Sunday and with great reflection. Immerse yourselves in meaning of confession- reconciliation. "Do not be afraid" and confess and do penance. Easter receipt of the Blessed Sacrament will have a greater meaning for you.

My Brother Knights,

Two weekends ago 10 Knights (from my council) and 90 men and woman from the parish were commissioned as "Extraordinary ministers of the Eucharist" (lay Eucharistic ministers) for our local area. In our there are 3 hospitals, numerous assisted living facilities and the home bound (a roughly 13 hundred home bound Catholics) and one priest to take them the Eucharist. This ministry required training, reading, reflection, prayer and Safe Environment Program (SEP) compliance. In one of the books describe this ministry as:

"To be a lay Eucharistic minister, it is vital to see one's ministry as a participation in his telling of the story of the God who pitched his tent among us in Jesus of Nazareth. The lay Eucharist minister shares in telling the story the Father and who continues to be encountered in the breaking of the bread. To say "the body of Christ" and hand a communicant the consecrated bread, to say "the blood of Christ" and offer the cup of salvation is to continue telling the story of God's saving action, God's self-gift among and on behalf of God's people." questions please feel free to contact the DM at any time.





### Administration and Finance Chairman's Message

Worthy Financial Secretaries/Faithful Comptrollers,

This is the sixth in a series of instructional messages about important administrative matters. <u>I ask that you</u> create a folder on your desktop and save every one of these to that folder so you can refer to it whenever <u>unsure</u>. Upcoming topics will include the survey of fraternal activity, Columbian Award report, budget, and possibly others. **Please save!** 

Elections of Officers for the upcoming fraternal year always take place at the May business meeting. <u>Preparations for this begin in February</u> with appointment by the Grand Knight (solely) of the Nominating Committee of three to five members. This committee meets in February and March with the task of identifying, arranging for permission from candidates for nomination, and developing a slate of nominees for each position to be filled. Positions required to be filled for a 1 year term except as noted by all councils include Grand Knight, Treasurer, and Three Year Trustee (3 year term). The Nominating Committee must name nominees for these three positions. Other positions to be filled for a 1 year term are optional and include Recorder, Chancellor, Warden, Advocate, Deputy Grand Knight, Inside Guard, and Outside Guard. There need not be nominees to all the optional positions, those should be filled in the order given above. The One Year Trustee and Two Year Trustee positions for the next year are <u>NOT</u> elected in the annual elections since those terms will not be expiring. Financial Secretary, Chaplain, and Lecturer positions are not elected since these officers are appointed. The Nominating Committee presents its slate of nominees (one per position) at the April business meeting.

While the Financial Secretary position is designed to be held by the same member for many years and over the long term to ensure stability and continuity of leadership, the Grand Knight position is only a 1 year term and is designed to be rotated through the membership to give the maximum number of members the opportunity to lead the council. It is frequently the custom to re-elect a Grand Knight to a second term, and in rare cases when other candidates cannot be found to a third term, but it is <u>NOT</u> ever acceptable for a Grand Knight to serve more than three consecutive terms. Such a situation is invariably unhealthy and endangers the long term survival of the council. The Nominating Committee must work to avoid this situation.

At the May business meeting, the slate of nominees is considered to be moved and seconded, and it is voted on as a single block. If it does not pass unanimously or if there is any objection or nomination from the floor then the positions are voted on separately. Positions must be voted on in the following order, and each position must be elected before moving on to the next position: Grand Knight, Treasurer, Three Year Trustee, Recorder, Chancellor, Warden, Advocate, Deputy Grand Knight, Inside Guard, Outside Guard. All officers elected take office on July 1st and not before.

Vacancies in officer positions due to death, transfer, or resignation sometimes occur in midterm. When these occur in any of the required positions (Grand Knight, Treasurer, One Year Trustee, Two Year Trustee, or Three Year Trustee) the vacancy <u>must</u> be filled by election at the next business meeting, normally within 30 days. The election is for the remainder of the original term (1 year for GK & Treasurer, 3 years for Trustee). It is never acceptable to leave these required positions vacant until the next annual election.





### **State Historian's Article**

My Brother Knights,

Each year has its own set of holidays related to seasonal changes or national celebrations. As we say farewell to winter and hello to spring, The Knights of Columbus celebrate occasions such as Valentine's Day, President's Day, St. Patrick's Day, and Mother's Day, just to name a few.

However, for us Catholics the major spring holiday is not those that are mentioned but the season of Lent. This forty-day season starts with Ash Wednesday, which will be on February 22<sup>nd</sup> this year, and ends on Palm Sunday. For many Christians around the globe, this season is considered the sacred time of the year.

Lent is a <u>liturgical season</u> of conversion that focuses on three spiritual pillars: prayer, fasting, and alms giving. During the 40 days of Lent, The Knights of Columbus are urged to reflect on their lives, perform acts of charity, and making sacrifices.
